DIRECTOR'S STATEMENT

Neighbors,

The NMCDC grew from the early 1990s Northside Neighbor Association (NNA), a group originally formed to work on the need for better bike and pedestrian access to Downtown and the Westside. After joining together on that issue, the NNA began the push for the creation of a democratically crafted neighborhood plan that could bring more stability to a neighborhood with low homeownership and high resident transiency - "the wrong side of the tracks." "Don't move; improve" became a catch phrase for neighbors who were planning to stay.

In 1996, with the help of St. Patrick Hospital, **I founded the NMCDC as a neighborhood nonprofit alongside the following inaugural board members:** Janet Bush (Northside neighbor); Perry Gleisman (Northside neighbor); Marga Lincoln (Westside neighbor); Ed Mayer (Missoula Housing Authority); Jim McGrath (Westside neighbor); Nancy Wilson (Westside neighbor); Chris Siegler (St. Pat's); Fred Simpson (Montana Rail Link); Judy Smith (WORD); and Linda Tracy (Northside neighbor).

The following four years of participatory democracy brought us the Northside-Westside Neighborhood Plan, an aspirational document that encouraged multiple improvements including several nonmotorized trail developments, Broadway safety improvements, open space trail connections, the Burns St. Food Hub, and preservation of the Moon-Randolph Homestead.

In 2000, the Neighborhood Plan warranted the NMCDC's formation of **Montana's first Community Land Trust** for entry-level, permanently affordable homeownership - now 54 homes in four neighborhood projects and poised to more than double in number of homes in the next two years. To learn of our neighborhoods' most compelling wishes, we're also now engaged with the City's planning department administration on the first comprehensive neighborhood survey since 2014, which will help guide the NMCDC's neighborhood advocacy and organizing work in the coming years.

HOUSING UPDATE

This year has been one of significant growth for the NMCDC's housing work in our community. We expanded our service area for our housing work to be City-wide and are on the cusp of bringing 20 permanently affordable and income restricted homes into our stewardship program. In addition to the tried-and-true community land trust model, we have begun **utilizing new tools and partnerships** to ensure that everyday people can continue to live in Missoula. We have, alongside Neighborworks MT, developed Montana's first cooperative/CLT hybrid housing model; worked with the City of Missoula and a Developer to ensure stewardship of deed restrictions on new income-restricted housing units; and are beginning a partnership with our local Habitat for Humanity affiliate to develop more community land trust homes for the Missoula community.



After two years of managing the Land Stewardship Program, I am looking forward to stepping into a new role as Executive Director of the NMCDC to bring the organization into this new phase alongside an excellent team of Board members and staff who recognize that collaborative and innovative strategies are required to solve Missoula's housing crisis.

Bob Oaks has been very generous with his time over the past two years in supporting my learning and growth and, more recently, in assisting in this leadership transition, and I am confident that we are positioned well to continue to build on the NMCDC's successes into the future.

2022 Housing Highlights

Wolf Ave Cooperative CLT

As a result of our organizing work and partnership with Neighborworks MT, eight households will soon become member-owners of the Wolf Avenue Collective! We received a grant from the Affordable Housing Trust Fund for \$340,000, which will support our work developing Montana's first cooperative/CLT hybrid model and our purchase of the land!

Rowe Condominiums

Thanks to Council leadership, eight homes on the Hip Strip will be reserved for households earning under 120% of the area median income through a deed restriction program. The NMCDC will steward these homes in perpetuity to ensure that they are used as primary residences and that the affordability is passed on to the next incomequalified buyers.

1918 Burlington

Due to the generosity of Marilyn Marler and David Schmetterling, alongside a grant from the City of Missoula, the NMCDC will soon purchase a home on three lots in the Franklin to the Fort neighborhood. Through this purchase, the current renter will gain permanent housing stability and we will add three townhomes to the large lots through a partnership with Habitat for Humanity of Missoula.

In 2023 we will continue our partnership with the City of Missoula and Ravara Development to bring more community land trust homes to the Northside, while supporting Northsiders in getting vital infrastructure needs met to accommodate our new neighbors!

LOOKING INTO 2023:

In October we **brought over 120 Northside and Westside neighbors together** to discuss prominent issues of concern. We launched our new neighborhood survey to help neighbors weigh in further on their priorities for community development, and we'll be out in the neighborhoods having more conversations around the survey and its results.

The NMCDC will also work closely and organize vigorously in the coming years, in partnership with Common Good Missoula and the City of Missoula CPDI Office, to **ensure robust and inclusive community input into the City's upcoming growth policy and zoning code reform efforts**, because we believe that decent housing is not a privilege but a fundamental right for all.
